Our Show Judges

Saturday's Sweepstakes and Altered Show Judge Pam Kilby | Solo Silkens

I've been involved in the dog community since I was eight years old. I started out as a junior handler showing my uncle's, and then my sister's, collies. It was there that I saw my first Borzoi and instantly fell in love. I knew that one day I would have one. It took me twenty years, but I did get my first Borzoi in 1991. I also was gifted an ex-track Greyhound the same year. I did obedience with him and he earned his CD in a weekend. I also garnered several obedience and rally titles on several of my Borzoi.

I got my first Silken in 2007 after losing one of my Borzoi. As much as I loved Borzoi, I wanted something with a little more longevity. Little did I know how much that dog would change the course of my life. I feel truly blessed to have had a breeder have enough faith in me to send me one of her good ones. I've been very lucky to have several breeders allow me to use their males to breed my girls.

To date, I have had three litters under the Solo prefix. I think my greatest accomplishment as a breeder is to have placed my puppies in fantastic homes.

In the show ring, I've also been truly thankful to have had some great success. Three of my dogs have won Best of Breed By Exhibitor three consecutive years at specialties. I've also won several Winners Dog/Bitch at specialties, as well as a couple of Best of Opposite Sex. We have also had a Best of Brood Bitch at a specialty as well. As well as a UKC Best in Show and a Best of The Best in Shows.

I am truly honored and humbled to be asked to judge these wonderful dogs.

Sunday's Specialty Show Judge **David L Kittredge**

I have been actively involved in pure-bred dogs since 1972, when I purchased my first American Cocker Spaniel for show and breeding. From then until 1996, I bred and co-bred many AKC champions under the Kittcar prefix, as well as handling some top winners.

I have been approved as an AKC judge since 1997, and currently judge the Sporting, Toy and Non-Sporting groups, as well as Miscellaneous classes, Junior Showmanship and Best in Show. I have been a UKC all-breed judge since 2005.

Some of the most memorable events in my judging career have been judging abroad in Great Britain, Europe, Scandinavia, China, Russia, South Korea and Australia, and I have had the honor of judging my own breed at the American Spaniel Club National event six times.

My approach to judging has always been to put overall breed type above any single attribute. It is important to investigate all the points addressed in a standard when evaluating an exhibit. However, I feel that, too often, the overall picture can be ignored in the final analysis. General unity of structure, harmony of proportion, functioning of the structure in movement, and correctness of all features for the breed's intended purpose is of greater importance than any factor considered separately. Of course, as a judge, I want it all!

NOTICE TO EXHIBITORS AND VISITORS

The ISWS, ECSW, and NJKC; their officers, directors and volunteers; and the East Coast Specialty Show Committee will not be responsible for dogs, persons, or personal property, nor do they assume responsibility for any incorrect entry, or for illness caught or spread at the event.

Entries: Exhibitors are encouraged to enter using the online entry form. The online entry form draws information from the ISWS registry which auto fills most of your dogs information which the process faster and helps with accuracy. If you find an error regarding your dog's information, email the show secretary or ISWS Registrar with the correct information.

PayPal is the preferred form of payment and the handling fee is included on the summary page. Owners are responsible for errors. Entries will be printed in the catalog exactly as they are listed on the entry forms. Entries changed or canceled must be received by the Show Secretary in writing or via email before the entry deadline, as listed in the premium. After close of entries, no dogs incorrectly entered in a class may be transferred to another class, nor canceled. **Entries will not be accepted without the proper signature and fees.** Entries must be submitted on approved entry forms.

Proof of dog's registration may be required.

The well-being of dogs, exhibitors and spectators is of paramount importance and, in the event it is necessary to cancel or stop the show before completion, no refund of entry fees will be made. Exhibitors should follow their veterinarian's recommendation to ensure their dogs are free of internal and external parasites, any communicable diseases & have the appropriate vaccinations.

Exhibitor Responsibilities: All dogs present must be held on leash or confined to their crates while on the premises. It is expressly understood that the exhibitors alone are responsible for the behavior of their dogs and/or children.

Judges will not wait for any dog holding up a class. Owners or agents alone are responsible for the presence of their dogs in the ring when their classes are called to be judged.

Notice: Anyone not acting in a responsible manner; or being disruptive, disrespectful, or acting in a dangerous manner can be ordered off or removed from the premises by action of Club members in charge, with no refunds made.

Conformation Classes

The age of an eligible dog is calculated as the first day of the show (11/11/23).

ISWS Conformation Classes (AKA what class do I enter my dog in?)

There are different kinds of classes in every ISWS Specialty show. There are Regular and Non-regular classes, Altered classes, and Junior Handler and Showmanship.

All approved shows must offer the Regular Classes. Some classes are "optional" and every sponsoring club decides which of these Optional Classes they also wish to offer. All of the regular classes are available for both dogs and bitches. Dogs are judged first, followed by bitches, preceded or followed by various non-Regular classes.

Below are descriptions of all of the classes. Use them to determine where you wish to enter your dog(s).

Regular Classes for Dogs and Bitches

In all puppy classes and the 12-18 months class, the age of the puppy is determined on the day of the show, not the date of entry or registration. First place in 6-9 month class (dogs and bitches) and 9-12 months class (dogs and bitches) will compete for Best Puppy in Show.

6-9 Month Puppy - For puppies that are at least 6 but less than 9 months old on the date of the show. (First place in this class will compete for Best Puppy in Show)

9-12 Month Puppy - For puppies that are at least 9 but less than 12 months old on the date of the show. (First place in this class will compete for Best Puppy in Show)

12-18 Month - For dogs at least 12 months of age and less than 18 months old that are not ISWS Champions.

Novice - For dogs at least 6 months old who have not, at the close of entries, won 3 first place prizes in the Novice class, nor a first place in the Bred By Exhibitor or Open classes, nor have they earned 3 points toward their ISWS championship.

Bred By Exhibitor - The Bred By Exhibitor class has the following requirements:

1. Six months of age or older on the date of the show.
2. Not a champion of record in ISWS on the date of the show.
3. Must be Owned or co-owned by any of the breeders of record on the date of the show.
4. Handler must be a breeder of record and an owner/co-owner of the entered dog. In any subsequent classes for which the dog becomes eligible there are no handler restrictions.

American Bred - For all dogs, except ISWS champions, who are 6 months of age or over, that were whelped in the US, by reason of a mating that occurred in the US.

Field Performance - For all dogs, except ISWS champions that have earned a performance championship for straight racing, oval racing, lure coursing or open field coursing.

Open - For any dogs 6 months of age or older.

Winners - Winners is not a class you enter. The right to go in to the Winners class is earned by having won a regular class. Following the judging of the Regular Classes each class winner will be called to the ring to compete for Winner's Dog. After Winners is awarded, the dog/bitch that was second in the same class from which the Winner came will be called to the ring to compete for Reserve Winners. The Winners Dog and Winners Bitch will compete for Best of Winners and Best of Breed. Both Winners Dog and Winners Bitch receive points toward their ISWS championship.

Best of Breed - For all ISWS Champions of record, plus Winners Dog, Winners Bitch, Best Veteran dog and Best Veteran Bitch.

Non-Regular Classes for Dogs and/or Bitches

3-6 Month Puppy - For puppies at least 3 but less than 6 months on the date of the show. (First place in this class will compete for Best Puppy in Show. They are not eligible for Best of Breed)

Altered Open - For all altered dogs (except ISWS or Altered ISWS champions) 6 months of age or over.

Altered Winners Class – NOTE: This is not a class you enter. The right to go into the Winners class is earned by having won an Altered class. Following the judging of the Altered Classes each class winner will be called to the ring to compete for Best Altered. After Best Altered is awarded, the dog of the opposite sex to the Best Altered will be awarded Best of Opposite Sex Altered.

Best Altered — The following are eligible to participate in this competition: a) Altered ISWS Champions; b) Altered Winners Dog and Altered Winners Bitch

Veterans- For all dogs/bitches 7 years of age and over. Classes are often divided into 7-10 years, and 10 years and over. **Both Veteran Dog and Veteran Bitch winners will compete in Best of Breed. These dogs will not receive any ISWS championship points.**

Stud Dog /Brood Bitch - The Stud Dog or Brood Bitch, along with at least 2 of their get, appear in the ring together. The stud dog or brood bitch must be shown in the ring with its get, although they do not have to be entered in the show. They must be entered in another class in the show to be eligible. Stud dog and brood bitch may be altered. The class is judged on the quality of the get. There are no common owners required.

Brace - A Brace is defined as two dogs that are similar in appearance, performing in unison and presented by a handler whose name is on both dogs as either an owner or co-owner. Both dogs do not need be to be intact, nor the same sex, nor entered in any other class at the show. They are judged 40% on conformation, 40% on matching looks, and 20% on difficulty of the match.

Junior Handler and Showmanship - These classes are for children aged 2 -18. Junior Handlers are divided into Junior Handlers I for 2-4 years old and Junior Handler II for 4-8 years of age. Junior Showmanship I is for children ages 8-12 and Junior Showmanship II is for ages 12-18. Junior Handlers must be accompanied/assisted in the ring by an adult. Any Junior may show any dog entered in any class, regular or non- regular, altered or in-tact, that is entered in the show.

Ribbons will be awarded First through Fourth placements in both the Regular and Non-Regular Classes.
